Refund and return policy

Purchases on the Réseau FADOQ's website will not be refunded, except in the case of a billing error on our part. Furthermore, if a member with a 24 months membership card with Réseau FADOQ dies before the last 12 months of his/her membership, Réseau FADOQ will reimburse the last 12 months of the membership.

Products shipped will be replaced only in the following cases:

- the product shipped differs from the one ordered;
- you received a damaged product.

In either of these cases, we will send you the correct product free of charge.

Security

Your online shopping on the Réseau FADOQ's website is secure. Your personal and credit card information are transmitted as an encrypted electronic signal that guarantees their confidentiality. The message cannot be intercepted, modified or decoded by a third party.

The Réseau FADOQ complies with SSL secure transmission standards. This means that your transactions are always forwarded in a secure manner. Moreover, your payment is made directly through Caisses Desjardins.

The Réseau FADOQ does not keep any electronic data or credit card information for any of its transactions. That is why you must provide your credit information again for each new transaction.
